
What is the Lunch With an Executive Program?

- MEIEA will now be including a silent auction at our annual conferences, to help raise money to defray the cost of the conference.
- We have created a type of silent auction item called “Lunch With an Executive”
- The winner of the auction for a particular “Lunch With an Executive” item will get to have lunch with the named executive.
- The specifics regarding the lunch are as follows:
 - The lunch is to occur within six (6) months from the date of the auction
 - The date, time, and location of the lunch will be agreed by the executive and the auction winner, and is expected to be in the local area where the executive is based.
 - The lunch will be at least 45 minutes long, and must provide the auction winner with one-on-one time with the executive.
 - The executive will pay for the cost of lunch.

"Lunch with an Executive" Program Agreement

I, _____ (name of executive) agree the following:

1. MEIEA may offer the prize of having a one-on-one discussion over lunch (the "Lunch") with me as part of the silent auction held at the 2010 MEIEA Conference.
2. MEIEA may use, in perpetuity, on a non-exclusive basis, my name and likeness in connection with promoting the "Lunch with an Executive Program".
3. The proceeds of the silent auction shall be considered a donation to MEIEA. I have no financial interest in these proceeds.
4. I am obligated to do the following:
 - a. Provide contact information to MEIEA to provide to the winner of the auction (the "Lunch Guest") pertaining to me. Such information will include the name of my assistant, if applicable, as well as a telephone number, email address, and physical address.
 - b. Have Lunch with the Lunch Guest. The Lunch will be at least forty-five (45) minutes in length and must provide the Lunch Guest with one-on-one time with me.
 - c. Schedule and hold the Lunch within six (6) months from the date of the auction, on a date, at a time, and at a location that is mutually agreeable by the Lunch Guest and me.
 - a. If the date, time, or location of the scheduled Lunch must be changed for some reason, I will use best efforts to reschedule the Lunch in a way that does not cause the Lunch Guest to incur any additional expenses or significant hardship related to participating in the Lunch.
 - d. Pay for the cost of the Lunch.
5. I am not responsible for any costs other than the cost of the lunch itself, including food, beverage, and gratuity. All other costs which may be incurred by the Lunch Guest in order to participate in the Lunch are the sole responsibility of the Lunch Guest.
